## **MINUTES**

## **EXECUTIVE CHAIRPERSON / PRESIDENT WELCOME**

Justin O'Donnell (Chapel Street Executive Chairperson & President) welcomed all guests to the 2017:18 Chapel Street Precinct Association (CSPA) deferred Annual General Meeting (AGM).

He noted that the time was 6.14 pm and that due notice of this deferred AGM was given.

Mr O'Donnell announced that as per the CSPA Rules of Association [clause 36] a quorum was present.

Mr O'Donnell also introduced Patrick Moriarty the CSPA governance contractor. He advised Mr Moriarty was overseeing the corporate governance of the AGM.

## **INTRODUCTION OF CSPA BOARD**

Mr O'Donnell introduced the 2017:18 board of directors and thank them for their support over the past 12 months:

#### **CSPA DIRECTION**

Mr O'Donnell covered the reasons CSPA deferred the AGM and talked about the changes that had been made for the collective benefit of the members. He read out the below:

CSPA was seeking to clarify critical constitutional matters including its membership process.

CSPA was responding to **important stakeholder feedback** and introducing significant business changes and a new 'member focused' direction.

CSPA was clarifying items pertaining to the **Chairperson's job description** and honorarium.

CSPA was wanting to implement a new member and director Code of Conduct.

## **ITEM ONE - CONFIRMATION OF PROXIES**

Mr O'Donnell declared the proxies had been ratified and Chris Voyias (Delphi Bank) held three votes in the room.

## **ITEM TWO - PREVIOUS AGM MINUTES 2017**

Mr O'Donnell tabled that the minutes from the Annual General Meeting held on 21 November 2017, were ratified by the Board and lodged with Consumer Affairs Victoria as required under the Act.

Mr O'Donnell then moved to resolve that the minutes of the previous Annual General Meeting, as posted on the Chapel Street member site (and provided as a handout), were accepted as a true and correct record of that meeting.

Mr O'Donnell asked if there were any corrections to the minutes. There were no corrections tabled and he noted they stand approved.

#### **ITEM THREE - CHAIRPERSON'S REPORT**

Mr O'Donnell tabled and referred all attendees to the President's Report detailed in the Annual Report 2017:18 on <u>page 4</u>. He advised attendees to take the report booklet with them and read in their own time (if they had not done so already). He also advised that the booklet included an overview and summary of the many marketing activities and events conducted over the past year for review.

### **ITEM FOUR - FINANCIAL REPORT**

Mr O'Donnell advised that the 2017:18 Chapel Street Financial Report had been independently audited by Collins & Co. He advised the CSPA treasurer had deferred her role and Mr O'Donnell tabled the financials.

## **ITEM FIVE - SPECIAL RESOLUTION**

Mr O'Donnell advised there were no special resolutions for ratification at the AGM.

### **ITEM SIX - ELECTION OF THE CSPA BOARD**

Mr O'Donnell called forward Patrick Moriarty to conduct the CSPA board election.

Mr Moriarty declared all positions vacant. He then read from below:

Under clause 50 of the Rules of the Association, we must decide via resolution the size of the incoming board. As such I request a vote to accept that the members confirm the recommendation of the CSPA directors that the size of the board of management shall be 10 people excluding the executive chairperson/president.

ALL THOSE IN FAVOUR - 16/16 AGAINST - 0/16 MOTION - CARRIED (unanimous)

Mr Moriarty advised that subject to the CSPA constitution clause 49 (4) separate elections must be held for each of the following positions -

- (a) Vice President
- (b) Secretary
- (c) Treasurer
- (d) General Committee

As per Clause 49 (5), if only one member is nominated to a position they must be declared the member elected to that position.

Mr Moriarty advised that CSPA received one nomination for each of the positions and the following members that nominated for the Chapel Street Precinct Association Board have therefore been elected unopposed.

## **MINUTES**

### **SGM VICE CHAIRPERSON / PRESIDENT [OPENING]**

Mr O'Donnell welcomed all guests to the Chapel Street Precinct Association (CSPA) Special General Meeting (SGM).

He introduced himself as the Chapel Street <u>Vice</u> President. He noted that the time was 6.44 pm and that due notice of the Special General Meeting had been given.

He declared as per the CSPA Rules of Association [clause 36 (2)] a quorum was present.

## **ITEM ONE - CONFIRMATION OF PROXIES**

Mr O'Donnell declared the SGM proxies had been ratified:

Chris Voyias (Delphi Bank) held three votes in the room.

### **ITEM TWO - PROPOSED SPECIAL RESOLUTION**

Mr O'Donnell explained that the special general meeting was for the purpose of considering and, if thought appropriate, passing the following special resolution. He read out the below:

The previous CSPA board unanimously believed that the changes to update the constitution are in the best interest of all members.

The proposed special resolution must be passed by three-quarters of the members who are present at the meeting and entitled to vote (in person or proxy) in accordance with section 64 of the Associations Incorporation Reform Act 2012.

Mr O'Donnell asked guests to read through the proposed constitutional changes outlined on the hand out placed on chairs. This was the same documentation that had been sent to all members 21 days prior.

Mr O'Donnell then took a few minutes in silence to give everyone a chance to read carefully.

Mr O'Donnell asked did anyone have any questions.

The below questions were asked:

### 1. What constitutes an Associate Member? Can you explain what a 'Logical Connection' means?

Mr O'Donnell explained that it is someone who has an interest in the prosperity of the Chapel Precinct Community and the CSPA board could value from their support.

# 2. What would be a reason why a member would not be accepted after application? What does at the discretion of the board mean?

Mr Moriarty explained no reason needs to be given but it would have to be a serious breach of the CSPA Code of Conduct, or that member had done something to bring the CSPA brand into disrepute.

# 3.Can you please advise in the half-senate who decides who has a 12-month term (to start with) and who gets a 2-year term? Would it be best to split the office bearers now?

Mr Moriarty explained that it would be decided by the CSPA board, in the first board meeting after the SGM. The board could draw straws or vote on how to split it. He advised this was at the CSPA boards discretion.

## 4. Does an owner get one vote per property?

Mr Moriarty explained that it was one application per property and one vote per property.

Mr O'Donnell also made sure everyone who asked a question was clear on the answer and felt comfortable to move forward. He then asked did anyone have any more questions. None were raised.

Mr O'Donnell then called for a vote to pass the CSPA special resolution:

ALL THOSE IN FAVOUR - 16/16 AGAINST - 0/16 MOTION - CARRIED (unanimous)
